Membership Terms and Conditions

I understand that upon payment of the Fees based on my Membership Selection and the Membership Add-Ons and Options that I selected, above, and upon acceptance by the Nest Golf Club Management of my application for membership, I will be entitled to receive only the benefits set out in the Membership Category Details above applicable to my Membership Selection(s). By paying such Fees or using the premises of the Club (as defined below), I agree to abide by these Membership Terms and Conditions. I understand that failure to abide by these conditions, in the Club and The Nest's sole discretion, may result in the revocation of my access to the foregoing benefits, in whole or in part, up to and including loss of membership.

For clarity, these Terms and Conditions apply only to membership for the purposes of the use of particular Resort amenities as set out herein, and is separate from membership in Big Bay Resort Association (which is governed by the bylaws of BBRA).

Rules and Regulations / Code of Conduct

I understand that adherence to the Friday Harbour Code of Conduct, as may be amended from time to time, and compliance with all applicable laws, is expected at all times by me, the additional persons listed above, my guests and the guests of such additional listed persons. I acknowledge and agree that non-compliance may result in withdrawal of privileges at the discretion of the Club or other disciplinary action as provided for in the policies of the Club, up to and including loss of membership. I will review the Member Guide issued to me, which includes copies of the Code of Conduct, the Disciplinary Policy, the Rules and Regulations of the Club, and other policies and procedures of the Club. I will comply with the foregoing policies, and any additional policies provided to me by the Club, for the duration of my membership. I have read and understand the descriptions on page 2 and 3 of this membership agreement outlining the privileges unique to each of the Membership Categories and I have chosen my Membership Selection accordingly. I acknowledge that I have had the opportunity to ask any questions about the Membership Categories and Membership Add-Ons and Options prior to entering into this membership agreement.

Personal Property

The Nest Golf Club and/or Friday Harbour Resort ("The Club") is not responsible for the loss or theft of, or damage to, personal property on the Club's premises, whether held in storage or not. This includes but is not limited to, golf clubs, golf bags, golf accessories, money, or other property. The Member will take all precautions to avoid loss or theft of, or damage to, personal property. In the event of such loss, or damage, the Member agrees to hold The Club harmless from and against any and all claims, actions, costs, expenses and demands in respect to such theft, loss or damage, however caused, arising out of or in connection with the use of The Club. As a condition of bringing a guest onto the premises of The Club, the Member agrees to assume all risk of loss or damage to personal property belonging to the guest. The Member agrees to indemnify and reimburse The Club for any liability, costs or expenses imposed by law upon The Club for any and all such losses.

Power Cart Rentals

The Member agrees to assume all risk of loss or damage to rented motorized golf carts rented from The Club as well as the risk of injury to the Member or other persons and damage to other property arising from the use of the golf cart. The Member will take all precautions to avoid loss or damage to the golf carts, damage to other property and injury to persons including the Member arising out of the use of golf carts. In the event of any loss, damage or injury, the Member agrees to hold The Club harmless from and against any and all claims, costs, expenses and demands in respect of such loss, damage or injury, howsoever caused. The Member agrees to indemnify and reimburse The Club for any liability, costs or expenses imposed by law upon The Club for any and all such losses.

General Waiver

The Member acknowledges that there are risks inherent in participating in the game of golf. The Member agrees to release The Club from any liability from personal injury property damage or loss sustained by the Member, including injury resulting in death and any financial loss or damage, directly or indirectly resulting from the Member's activities or participation in events at The Club. The Member further waives, as against The Club, all claims, recourses, and rights of action that the Member may have against The Club as a result of such personal injury, property damage or loss.

Cancellation & Refund Policy

This agreement may be cancelled by the Member(s) within 10-days of acceptance of this agreement by the Nest Golf Club for a full refund. After the 10-day period and up to the commencement of the golf season as outlined in this agreement, any cancellations will be subject to a minimum Administration Fee of 15% of the total fees due. Cancellations requested after the official opening date and up to May 31st are subject to a minimum Administration Fee of 20% of the total fees due, regardless of the number of games played. No refunds or credit will be granted for any cancellation requests made by the Member(s) after May 31st of the Golf season as outlined in this agreement.

Delayed Opening/Temporary Amenity Closure Policy

Should the Nest Golf Club be unable to fulfill its obligation to Members with regards to opening of the Club or be subject to a temporary closure, the Member(s) will be presented with the option of receiving either a refund of fees paid or a credit towards the fees of the subsequent golf season. For instances of a delayed opening, this policy will be implemented only upon the approval of the Friday Harbour Executive team, and no sooner than June 1st of the golf season as outlined in this agreement. For instances of a temporary in-season closure, this policy will be implemented only upon the approval of the Friday Harbour Executive team, subject to a minimum 1-month closure. The rate of refund or credit will be determined as per the table below:

Duration of Closure	Refund	Credit	Est. % of Season Lost
15 days	7.5%	10%	8.65%
1 month	15%	20%	17.3%

For periods of extended closure, the refund or credit based on the table above may combined to provide an aggregate refund or credit. Example: A 2-month delayed opening may provide The Member with the option of either a 30% refund or a 40% credit towards the fees of the following golf season.

Termination

This Agreement shall remain in full force and effect for the term set out on the front page hereof, unless terminated earlier as a result of the following conditions: a) The destruction of the Club's facilities, including but not limited to buildings, property and/or the course; b) Any breach of this agreement, including by not limited to the Nest Golf Club's Rules and Regulations and/or Code of Conduct by the Member; c) Non-payment of fees as outlined on page 6 of this agreement, in part or in full by the dates listed. The Nest shall provide the Member with notice as such termination in writing by personal delivery or by registered mail to the Member's address provided in this Agreement. Notice by registered mail shall be effective eight (8) days after it is mailed. Upon termination, any amounts paid to the Nest under this Agreement shall be applied to any sums owing to the Nest for service, repair, storage, amounts for outstanding claims, and any further amounts owing under this agreement, and the balance thereof, if any, shall be deemed to be forfeited by the Member and shall be retained by the Nest for its own use. If, after the Nest has applied all amounts paid to it by the Member under this Agreement, as aforesaid, there is a deficiency, then the Member shall promptly pay the Nest the full amount of such deficiency, upon receipt of the Member of a notice listing such amount.

Non-Transferable

I understand that my membership is not transferable at any time and does not confer upon me any ownership for the property/assets of The Nest Golf Inc. or Friday Harbour Resort ("The Nest", or "Club"). I acknowledge and agree that this membership is valid only for my personal access/green fees and for those listed in this agreement for the duration of the season and that the management of the Nest reserves the right to set the annual fee and the right not to renew an application for the next season, for any reason whatsoever. I acknowledge that if my application is renewed, these Membership Terms and Conditions, as may be amended from time to time on notice, will continue to apply. The Club will provide 30 days prior notice of my option to request renewal of my membership.

Jurisdiction

This Agreement shall be governed in accordance with the laws of the Province of Ontario and the federal laws of Canada applicable therein.

Consent and Acknowledgement to Collection, Use and Disclosure of Personal Information

I hereby consent to the collection, use, and disclosure of my personal information and the personal information of the additional persons listed above, as provided in the membership / agreement, by the Club, the Nest and their authorized agents for the purposes of administering my Membership, the Memberships of the additional listed persons above, and providing associated with membership to me and the additional persons listed above (the "Purposes"). I confirm and represent that I have obtained the authorization and consent of the above additional persons listed above to provide the above-noted consent on their behalf for the Purposes. I give permission to the Nest to share my personal information with Golf Ontario & Golf Canada for the purpose of receiving information from them and to activate my Golf Canada account for handicapping purposes.

I certify that I have read and fully understand this consent and release, and that all questions pertaining to this consent have been answered to my satisfaction.

Photography Release

I, the undersigned, give permission to Friday Harbour Resort, and/or parties designated by the Friday Harbour Resort to photograph/video me and use such photograph(s)/video(s), my likeness, image, name, voice and persona, in all forms of media or format, whether now known or hereafter developed, at any time or times in perpetuity, for any and all promotional purposes including advertising, display, audiovisual, exhibition or editorial use.

I understand and agree that I will not receive further notice or compensation or royalty for the publication or use in any manner whatsoever, of such photograph(s)/video(s), my likeness, image, name, voice and persona and I hereby release Friday Harbour Resort and/or any parties designated by Friday Harbour Resort from any liability with respect hereto.

Acknowledgement
