Non-Transferable

I understand that my membership is not transferable at any time and does not confer upon me any ownership for the property/assets of The Nest Golf Inc. or Friday Harbour Resort ("The Nest", or "Club"). I acknowledge and agree that this membership is valid only for my personal access/green fees and for those listed in this agreement for the duration of the season and that the management of the Nest reserves the right to set the annual fee and the right not to renew an application for any reason whatsoever.

For clarity, these terms and conditions apply only to membership for the purposes of the use of particular Club amenities, and is separate from membership in Big Bay Resort Association (which is governed by the bylaws of BBRA).

Cancellation Policy

I understand that my membership is non-refundable 10 days after my application is submitted and accepted. After this 10 day period, requests for cancellation will only be considered under special circumstances. A cancellation request form must be submitted outlining the reasons for cancellation. Cancellations under the terms of Special Circumstances are at the sole discretion and approval of Department and Executive Management and will be reviewed on a case-by-case basis. An administrative fee may apply. Negative category adjustments related to membership type will not be permitted during the active season, therefore please choose the membership that is best suited to you and your playing requirements.

Rules and Regulations / Code of Conduct

Adherence to the Friday Harbour Code of Conduct is required at all times. Non-compliance may result in withdrawal of privileges at the discretion of the Club or other disciplinary action as provided for in the policies of the Club, up to and including loss of membership. Please review the code of conduct and disciplinary policy outlined in the member guide issued to you. You will receive a Member Guide that outlines the Rules and Regulations, policies and procedures. You will review this document and are subject to these guidelines for the length of your membership. I have read and understand the descriptions on page 2 and page 3 of this application outlining privileges unique to each of the membership categories and I have chosen as indicated within and below.

Power Cart Operation and Damage Release

I shall defend, indemnify and hold harmless the Club and all other Releasees against any and all losses, damages, liabilities, deficiencies, claims, actions, judgments, settlements, interest, awards, penalties, fines, costs, or expenses of whatever kind, including reasonable legal fees, in connection with any third-party claim, suit, action or proceeding arising out of or resulting from my use of the power cart or golf course.
